Method of reporting from 1 August 2021

Any large piece of electrical equipment with at least one dimension exceeding 50 cm is reported as Group 4 Large equipment without further differentiating the type or weight; **a flat recycling fee applies**

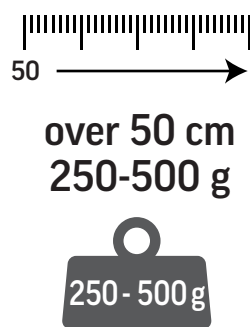
Electric track systems, clothes and footwear with electronic components, extension and connecting cables, electric and electronic toys, musical equipment, and other equipment **with at least one dimension exceeding 50 cm and with a weight of up to 250 grams (inclusive)**



This subgroup will be reported on a separate line, and there will be **a recycling fee of CZK 0.50 per piece**

Any large piece of electrical equipment with at least one dimension exceeding 50 cm is reported as Group 4 Large equipment without further differentiating the type or weight; **a flat recycling fee applies**

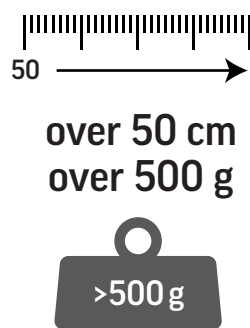
Large luminaires, electric track systems, clothing and footwear with electronic components, extension and connecting cables, electrical and electronic toys, musical equipment, and other equipment with at least one dimension exceeding 50 cm and with a **weight of over 250 grams but not more than 500 grams (inclusive)**



This subgroup will be reported on a separate line, and there will be **a recycling fee of CZK 1.00 per piece**

Any large piece of electrical equipment with at least one dimension exceeding 50 cm is reported as Group 4 Large equipment without further differentiating the type or weight; **a flat recycling fee applies**

Large luminaires, electric track systems + washing machines, dishwashers, electric stoves, microwave ovens, music equipment, and other equipment **with at least one dimension exceeding 50 cm and with a weight of over 500 grams**



This type of electrical equipment will be reported under Group 4 as before, but the **recycling fee will be CZK 9.50 per piece**

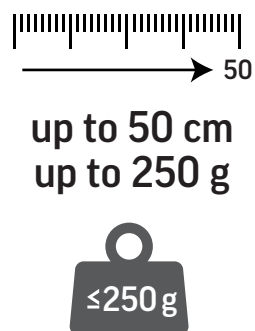
Method of reporting until 31 July 2021

Any small piece of equipment without further differentiating the type or weight, where none of the dimensions exceed 50 cm; **a flat recycling fee applies**

Types of electrical equipment

Drivers, starters, circuit breakers, dimmers, contactors, relays, small luminaires, radio receivers, video cameras, electric and electronic toys, sports equipment, and other equipment **with a weight of up to 250 grams (inclusive), where none of the dimensions exceed 50 cm**

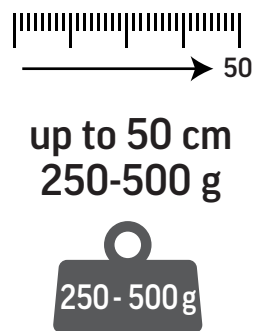


Method of reporting from 1 August 2021

This subgroup will be reported on a separate line, and there will be **a recycling fee of CZK 0.50 per piece**

Any small piece of equipment without further differentiating the type or weight, where none of the dimensions exceed 50 cm; **a flat recycling fee applies**

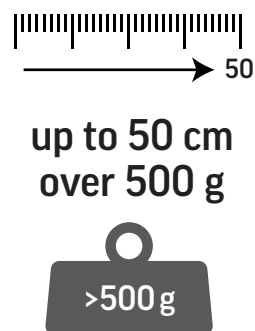
Drivers, starters, circuit breakers, dimmers, contactors, relays, small luminaires, radio receivers, video cameras, electric and electronic toys, sports equipment, and other equipment **with a weight of over 250 grams but not more than 500 grams (inclusive), where none of the dimensions exceed 50 cm**



This subgroup will be reported on a separate line, and there will be **a recycling fee of CZK 1.00 per piece**

Any small piece of equipment without further differentiating the type or weight, where none of the dimensions exceed 50 cm; **a flat recycling fee applies**

Small luminaires + vacuum cleaners, sewing machines, irons, toasters, razors, scales, radios, video cameras, electric and electronic toys, sports equipment, and other equipment **with a weight of over 500 grams, where none of the dimensions exceed 50 cm**



This type of electrical equipment will be reported as before under Group 5, **and there will be a recycling fee of CZK 4.00 per piece**
